### **Report of Factual Findings**

We have performed the procedures agreed to by management of **Kepwealth Property Phils.**, **Inc.** (the Company) with respect to the Progress Report of the Company as at and for the quarter ended December 31, 2023 on the application or use of the proceeds from the Initial Public Offering (the Offering) of the Company's common shares in connection with its compliance with the reportorial requirements of the Philippine Stock Exchange (PSE). Our engagement was undertaken in accordance with the Philippine Standard on Related Services 4400, Engagements to Perform Agreed-upon Procedures Regarding Financial Information, applicable to agreed-upon procedures engagements.

### Background
